From the New Mexico Livestock Board

Vesicular Stomatitis: New Mexico & LEGAL Hauling Requirements.

De Baca county Vesicular Stomatitis quarantined premise will be released July 29, 2009
Valencia county premise is scheduled to be released on August 18, 2009.

The following rules will be in effect as long as New Mexico has Vesicular Stomatitis quarantined premises.

Livestock, including horses being shipped out of state need to meet requirements of receiving states.

All County, Livestock Fairs or Expo's are to have a veterinarian available to examine exhibition livestock including equines prior to entering exhibition grounds.

Counties with positive quarantined premises for Vesicular Stomatitis shall be required to obtain the following.

Health Certificates for equines leaving the county for group gatherings such as, Exhibition ,rodeos, large trail rides ,ropings

Health Certificate must be obtained no later that seven days prior to exhibition.

Livestock, and equines leaving affected counties with quarantined Vesicular Stomatitis premises must have livestock inspection prior to movement.

The preceding measures have been implemented to prevent disruption of interstate livestock movement and to prevent exposure to Vesicular Stomatitis at livestock exhibitions and events.

Vesicular Stomatitis exposure at an event will result in extensive quarantines and could involve the entire premises and all livestock at the event.
